# Prisoner re-entry attracts leaders from across the state

Prisoner re-entry is a critical part of public safety. Each year 17,000 people are released from state prisons. Of those, 95% return to their former communities.

# Sheriff's Office Weight Loss Challenge Encourages Healthy Habits



Sergeant Janet Robbins is a huge fan of NBC's hit television show "The Biggest Loser". So she mimicked the show and organized a weight loss challenge for the Newport News Sheriff's Office. It all started with her own effort to lose weight. She says the Newport

News Sheriff's Office Biggest Loser contest was a way to address deputy health and wellbeing. "Remember, at any given moment we may have to respond to a signal. That emergency call could be on any floor of the jail or at the courthouse, and we have to run there," she said. Reaction time is slower for those deputies who are carrying extra weight.

Holly Hicks, R.D. agrees. Hicks is a registered dietician at the Riverside Wellness & Fitness Center. She explained, "Food plays a vital role in our energy level, alertness, and focus. All things important in your law enforcement field." Food is fuel, and you want the right type of fuel. Hicks went on to say, "Certain foods, like carbohydrates, digest quickly. So you might eat a bagel for breakfast and be hungry a couple of hours later."



Jane B. Brown from the Governor's Office; State Delegate Glenn Oder; Mayor McKinley Price; and a coalition of community partners that provide re-entry services. As many as 60 people attended this meeting.

"Re-entry is ultimately about public safety," said Sheriff Morgan.
"Do we want them to come back as good neighbors?" asked Morgan of how society wants to accept ex-offenders back into the community.
"Or do we want them to come back without a job, without a place to stay, and resort to crime and behaviors that got them into trouble to begin with?"

Speaking at the event were three ex-offenders who provided valuable insight into what aided their successful transition from prison to community. Jason Brumbaugh was one of those ex-offenders and told of his good fortune in finding employment, "I realize that I've been given an opportunity that so many others, whether ex-felon or not, could only hope for in this current economic situation where money is tight, and jobs are hard to come by."

In his speech,
Brumbaugh echoed the
sentiments of so many other
ex-offenders, "Unemployment and idle
time increases the chance that a person
may commit a crime and go to jail.
Then when that person is released,
he/she is now more likely to stay
unemployed, mainly because private
business owners do not often hire
convicted felons anymore. The door
keeps revolving."



Newport News TV covered the event for the half-hour long news program called "Inside Newport News."

A number of people attending the re-entry breakfast were business owners. Part of the strategic plan will include appealing to local businesses to open their doors to ex-offenders who have shown a willingness to change. •

She recommends including proteins in a meal because it will stay with you longer. For example, "add an egg to that breakfast and make the bagel a wheat bagel for fiber, and you will have more energy and won't get hungry right away."

A total of forty-two employees enrolled in the Biggest Loser contest. There are deputies, civilian staff, and contract employees all wanting to drop weight and get healthier. Proper diet and exercise can help protect against diabetes, heart disease, and cancer -- all among the leading causes of death in this country.

As part of her rules, Robbins developed a cash prize. Here's how it works: Each contestant put-up \$20 to enroll; they pay a \$1 fee every time they weigh-in on a bi-weekly schedule; and if they gain weight,

they owe a buck for every pound gained. All of the money goes into the prize pot. Sheriff Gabe Morgan was so supportive of the idea that he nearly matched the fund. Approximately \$1,500 will be shared between the 1st, 2nd, and 3rd place finishers. The winners will be calculated by the largest *percentage* of body weight lost.

The contest began April 8. The last weigh-in will be July 29. As of June 17, the total weight loss for the group was 196 pounds.

For those who want a little help reaching their personal weight goals, Riverside Wellness & Fitness Center has a two month program called "Diet-cise" that combines healthy meals with fat burning exercise. Hicks says they conducted a follow-up after a year and discovered that 82% of their clients either maintained the weight loss from the program or had continued to lose more. •

# Sheriff Gabe Morgan accepts invitation to speak at national training conference.

#### American Jail Association offers information on current issues affecting the correctional industry

Sheriff Gabe Morgan has once again hit the national stage. In March of this year, Morgan testified on the nation's capitol where he asked members of Congress to invest in evidence-based intervention programs for youth offenders. Such programs are effective in turning around the lives of young people and giving them the tools to grow into productive adult citizens.

Most recently Sheriff Morgan was a presenter at the American Jail Association (AJA) 30th Annual Training Conference & Jail Expo held in May, 2011. The topic of the workshop he co-presented with Liz Ryan, CEO of the Campaign for Youth Justice, and with Liane G. Rozzell, Executive Director of Families and Allies of Virginia's Youth, centered around the challenges of incarcerating young people in adult jails.

Morgan talked about the efforts being made by the Commonwealth of Virginia to protect children from the dangers of adult jails.

Ryan discussed
what is happening on a federal level to
protect youth offenders. There is
reauthorization legislation and amendments
to the Juvenile Justice & Delinquency
Prevention Act (JJDPA) moving through

Congress. The amended version of the law would disallow the placement of children in adult jails. As a condition for funding, it

> would require states to keep juvenile offenders out of adult jails. It also would require states to address the disproportionate minority contact with the justice system. Jail officials can be instrumental in supporting the reform effort to strengthen the

core protections of the JJDPA.

Ryan and Morgan cited research behind the new legislative positions. •

Consultants with Neighborhoodwork America conducted training in May for residents and members of the W&S Steering Committee.
